

- (iii) The meetings of governing body shall be held once in every month to conduct the activity of the Society.
- (iv) That for every meeting of the Society minimum 33% of member shall be the quorum.

Assets of the Society

- The subscriptions made by the members shall form the assets of (i) the Society

- (iv) That the Society can purchase movable and immovable property for establishment of institutions of the Society

- That the Society can sell, mortgage and take any loan from (vi) financial institutions for full filling the objects of the Society
- (vii) The assets of the Society shall be applied towards achieving the objects of the Society and no part of it shall be divided in between the members of the Society.
- That the assets of the Society shall be spent by the General (viii) Secretary in consultation with the governing body.
- That the President shall have veto power for stopping any (ix) investment.

8. **Audit**

- That the proper account book of the Society shall be maintained by (i) the Governing body
- (ii) That the audit of all the accounts of the Society shall be got done from a qualified auditor every year.
- (iii) That financial year of the Society shall begin from 1st April every year and shall and down 31st march of every year.

9. Disqualification of members and office bearers

- that if any member acts against the object of the Society he shall be dismissed from the membership of the Society by the governing body.
- (ii) That if any member of the governing body act against the object of the Society he shall be dismissed from the Society by 3/4 majority board of the governing body.

10. Winding up of the Society

- (i) That if the governing body of the Society thinks that the Society is no more able to achieve the objects of the Society then it can pass the resolution by 3/4 majority board for winding up the Society
- (ii) That in this case first the liabilities of the Society shall be cleared
- (iii) That in case any assets are still available after paying the liabilities then the same shall be paid to some other Society having the same objects.
- (iv) That no part of assets of the Society shall be divided in between the members of the Society.

11. Powers of governing body Members

(i) President

President shall manage the society as per the directions of the Governing body. He shall manage the society in consultation with the Governing body of the society.

(ii) Vice President

The vice president shall act as president in the absence of president and shall do ther activities as entrusted by the president,

(iii) General Secretary.

- a) General Secretary shall conduct all the meeting of the society smoothly. He shall inform all the member of the society about meeting and sell keep all the records of meeting in the minutes book.
- b) He shall have the powers to sanction an expenditure of Rs. 50,000/- in a month without reference to the executive body.
- c) He shall pass the salary and other contingent bills of school as allotted in the budget.
- d) He shall exercise general control and supervision over to affairs and finances of the school.
- e) He shall deal with and sign all the correspondence on behalf of the society.
- f) He shall have the power to appoint and dismiss the teachers and other employees in consultation with the president/governing body.
